

Tuition, Fees and Payment Schedule **For all Courses**

DUE UPON ACCEPTANCE:

- Course registration fee in order to have your name on the waiting list.
- 20% deposit on tuition (if paying in cash)
- Kits must be purchased prior to starting classes (if paying in cash)

REMAINING TUITION:

- Amount is divided by the number of payment periods to arrive at a payment.
 - All tuition and fees must be paid prior to last day of attendance.
- Payments may be made Weekly, bimonthly, or monthly
- 15% interest on any unpaid balance

Financial Aid Application Information

PELL GRANTS:

Pell Grant applications may be filled out online, using the school website above, and click "related websites" then click on "FASFA on the web". You will need to have the following information on hand in order to complete your application:

- ✓ Federal Income Taxes for 2009 (*for the 2010-2011 award year if you plan to start prior to start prior to July 1st, 2011.*)
- ✓ Federal Income Taxes for 2010 (*for the 2011-2012 Award year if you plan to start after July 1, 2011 **OR** if you are a current student and will still be attending after July 1st, 2011.*)

Our School code is 017178. If you want to find out immediately how much you are eligible for you must do the following:

- ✓ Choose "Fill out FAFSA" which is the top line of box 2.
- ✓ On the left side there is an option to "apply for a PIN number", click on this option. You may choose to have the computer assign your PIN and it will be sent to your email address OR you may choose your own PIN number (this is quicker) and you can then complete the FAFSA application process.
- ✓ Remember if you are a dependant student, your Parent must also apply for a PIN to sign electronically.
- ✓ If you are under 23, not married, and have no children you are considered a dependant and your parent must fill in their financial information as well and **MUST** also sign the application.
- ✓ When you come to the end of the application it will ask you to sign it. Select "sign with PIN" and enter your PIN #. If a dependant, your parent must also enter and sign with their PIN as well. After entering your PIN #'s click, "Submit my FASFA now" button and you will come to a confirmation page, make sure you PRINT that page. There is a number called the EXPECTED FAMILY CONTRIBUTION.
- ✓ If you call our Financial Aid Administrator, they can estimate what you will receive from a Pell Grant. Keep in mind you may still be required to provide verification information to the school.

STUDENT LOANS:

It is suggested that our students apply for student loans by completing an electronic master promissory note at the following link, www.Studentloans.gov . Please make sure that you **print a copy** to turn in with your required documents for our records.

Until you start school no further action is required. Your eligibility is based on financial need and not your credit score. The amount varies based on what you may receive for a Pell Grant and what your cost of attendance is.

A nail kit, uniform, and books must be purchased by the student. These items must meet the specifications set by the school. (Kit cost if purchased through the school is **\$1,200.00**. Price subject to change)

Full NT Program including Books, uniform, registration and kit = \$3,610.00

INSTRUCTOR TRAINING STUDENT FEES:

- Tuition \$8,000.00 (1,000 hour course) \$4,000 (500 hour course)
- Registration \$150.00
- Total Due \$8,150.00 (1,000 hour course) \$4,150.00 (500 hour course)

Books and uniform must be purchased by the student. These items must meet the specifications set by the school. (Cost if purchased through the school is **\$517.00** Price subject to change)

Full 1,000 hour course including Books, uniform, registration and kit = \$8,667.00

Full 500 hour course including Books, uniform, registration and kit= \$4,667.00

ESTHETICS STUDENT FEES: (600 hour course)

- Tuition \$4,320.00
- Registration \$150.00
- Total Due \$4,470.00

Books and uniform must be purchased by the student. These items must meet the specifications set by the school. (Cost if purchased through the school is **\$800.00**. Price subject to change)

Full EST Program including Books, uniform, registration and kit = \$5,270.00

HAIRCUTTER STUDENT FEES: (900 hour course) *NOT CURRENTLY AVAILABLE*

- Tuition \$3,838.50
- Registration \$150.00
- Total Due \$3,988.50
